Q I am already getting free medical care. What more does this program offer me?

Q I have not been a legal permanent resident for 5 years and I am not a U.S. citizen. Can I still get medical care at the county facilities or my local clinic?

A You need your documents in order to get the additional benefits that come with the new Healthy Way LA program. If you do not have any documents, you can still get the medical care you have been getting from us or other clinics or health centers.

HOW TO ENROLL IN HEALTHY WAY LA?

To enroll in Healthy Way LA, please bring proof of identity and citizenship or legal residency to your hospital, comprehensive health center, clinic or health center. Also, bring proof of income, if available.

What documents do you need to bring?

Bring ONE of the following original documents which will be photocopied and returned to you:

- U.S. Passport,
- Certificate of Naturalization,
- Certificate of Citizenship, or
- Permanent Resident Card (Green Card).

Or bring the following TWO documents:

1) U.S. Birth Certificate or Military Discharge Form DD214

AND 2) Driver's License, School Identification with Photo, or U.S. Military Identification Card.

For income verification, please provide one of the following:

- A month's worth of paycheck stubs
- Copy of last year's federal income tax return
- Signed letter from your employer that shows the gross amount paid and the date of paycheck being reported.
